Enrollment Requirements

Minimum age accepted is six weeks.

Immunization Verification

A current "Certificate of Immunization" is required of all children. You may obtain an immunization form from your pediatrician.

Application Fee

A processing fee of \$25 collected when an application is submitted and child is placed on the wait list.

Special Fees

Individual enrichment programs may require additional fees, i.e., field trips, Bailey Dance, Head-Over-Heels Gymnastics, Playball, Soccer Shots, Aces & Birdies, etc.

Payment

Parents/guardians are expected to pay for the number of days and/or service for which they have contracted, including weeks with holidays, days the child may be absent due to illness, or days the child attends only a partial week.

New participants enrolling in the **Full Day Care Program** are required to pay a one-time nonrefundable \$200 Commitment Fee.

New participants enrolling in the **Morning Instruction Only Program** are required to pay a one-time non-refundable \$100 Commitment Fee.
